- 1. Over the last decade, the discipline has moved from being oratory centered to include courses in political, health and gender communication among others. We have therefore changed the title of our program from "Speech Communication" to "Communication Studies". All courses in the department will effective AY 16-17 carry have the suffix COMM instead of SPCH. We would like COMM 77W-Z and COMM 78W-Z to mirror the rest of our courses for continuity.
- 2. COMM 77W-Z and COMM 78W-Z are mostly taken by our majors. Most regional and national institutions at the behest of National Associations in our field and Communication Transfer Model Curriculum taskforce have renamed their courses to Communication Studies. This change will therefore make it easier for our majors and transfer students to transfer; receive credits for their work; and effectively articulate their skills in today's job market.
