- Zain M: EPAC met and talked about an annual review, procedures for computer information, planning for classroom and conference technology, and deployment of technology that enables disabled people.
- Amy H:
 - Chancellor's advisory council:
 - Chancellor Miner distributed a survey via email on February 14, 2023, requesting feedback by February 23, 2023, from both our students and employees about whether the district should consider ending the district's COVID-19 vaccine mandate for students and employees.
 - Some of the reasons to lift vax mandate are: the end of California's COVID-19 state of emergency, abandonment of plans for a statewide vaccination requirement for K-12 students, and other CCs. Currently there are only two colleges within CA Community College that still mandates vaccine, and De Anza is one of them.
 - There were lengthy discussions, ultimately decided that the bargaining unit JLNBC will work with classified and faculty unions to determine what timing is good for lifting the vaccine mandate (Spring, Summer, or Fall), and what safeguards will be in place (masks, hand sanitizer, etc).
 - Affordable Housing Task Force:
 - Affordable housing task force presented its strategic asset evaluation survey.
 - The purpose of this evaluation is to evaluate what criteria and needs De Anza and Foothill college has, and to use this data as a requirement when looking at affordable housing.
 - This evaluation is done in 4 parts:
 1. educational outcomes
 2. enrollment/employee management
 3. Campus community
 4. Sustainable operations
 - This evaluation is gone over with school presidents and student body presidents of FHDA, and we discussed where it would land on a number scale.

College Council:

- Approved RAPP committee governing documents to be official
- By majority vote, recommended to President Holmes for De Anza to become a Smoke-free campus. This is to limit hazing and peer influence for students to go into substances.
- Talked about Measure G and the potential formation of a new college oversight committee.

Touch base with Dr. Holmes:

- The class shortage for MATH1B and ART8B was brought up again, will be forwarded to VP of Instructions.
- There were certain professors that were reportedly teaching during the power outage. It was not safe practices and all reports have been forwarded to HR to be dealt with on a case-by-case basis.

General update from facilities:

- The tree that fell in front of the De Anza sign has been cleaned up. The fencing was damaged.
