Hello All,

At the May 8<sup>th</sup> Board Meeting, President Ahrens requested an update at the July Board Meeting addressing the following:

- Determine the total amount of budget currently allocated for the "Mega Project", including the Services for Student Building and Swing Space for the Arts Quad.
- Provide ballpark estimates for projects that might be utilized in place of an Events Center.
- Assuming the De Anza Event Center does not move forward, propose a reallocation of the funding that had previously been assigned to the De Anza Event Center.

To accomplish these goals, please provide the following to me by May 31st.

- From De Anza:
  - Dollar amounts of the anticipated budget amounts that would be or are allocated to the Services for Students Building and Arts Quad Swing Space.
  - A list of projects that might be utilized in place of the Event Center, along with a general concept of size and function. For example, if a "Student Union" were envisioned, please define exactly what functions it would serve and what size of building would be anticipated. Some projects that were mentioned at the Board Meeting.
    - Updating Conference A/B and Smithwick
    - Updating the Arts Quad
    - Building a multi-user building (see note above)
    - Building a Student Union
  - In addition to the Event Center location, a list of either existing projects that were cut from the current bond list or new projects that have become priorities and are still eligible for bond funding.
- From Foothill:
  - Desired improvements to the Smithwick.
  - A list of either existing projects that were cut from the current bond list or new projects that have become priorities and are still eligible for bond funding.
- From Central Services:
  - Remaining Event Center budget after the utilities relocation and demolition

- of the Flint Center are allocated.
- A list of either existing projects that were cut from the current bond list or new projects that have become priorities and are still eligible for bond funding.
  - ETS
  - Vehicles
  - Electrification
  - Mechanical
- Estimates for escalation/Inflation

After the information is submitted, Gilbane and Joel Cadiz will work up some ballpark cost estimates to evaluate whether the projects are economically feasible. I will work with Business Managers and then Cabinet to provide options for allocating the Event Center funding across De Anza, Foothill and Central Services based on the information that we obtain.
