In this class you will be presenting 5 speeches. Two of the speeches will be less formal and function as warm up, ice breaker speeches. The following three speeches will require significant preparation including a written outline, visual aids and documented research.

You will also be writing peer critiques, self critiques and a critique of a Ted Talk.

There are quizzes based on the reading and on a series of library research videos you will watch.

You will develop skills as a supportive audience member
